



RULES & GUIDELINES

DotDM Corporation, Commonwealth of Dominica ccTLD (.dm)

Last Modified: 14 January 2025 v1

The following Rules and Guidelines are incorporated by reference into the DotDM Corporation's ("DOT DM") Registration Agreement.

.DM Domain names shall be registered on a first-come, first-served basis. A registrant's offer to register a .dm domain may be denied at the sole discretion of the .DM Registry, particularly if the domain under offer is found to be potentially injurious to the Laws, Morals, or Cultural and Diplomatic Sensitivities of the Commonwealth of Dominica and the People of the Commonwealth of Dominica.

Such discretion may also be applied once the Registrant's offer to register a .dm domain has been granted. .DM Registry may decide to revoke a .DM Domain name at any time, should .DM Registry determine that the use of such .dm domain is not made in accordance with the requirements of the .DM Acceptable Use Policy or those of any applicable Policies, Laws and/or Regulations. DM Registry may also decide to revoke a .dm domain name if the domain name deviates from the original stated use and basis for acceptance of the registration.

It is recommended that .DM Policies be reviewed at <https://nic.dm/policies.php> prior to submitting an offer for registration to ensure compliance with current .DM Policies

Who may register and what types of .dm domain names are available for consideration for registration

Requests for registration of **.dm** and **.co.dm** Domain Names are open to all entities and individuals within or outside of the Commonwealth of Dominica with no domicile requirements.

Registrations may be accepted for Second Level **.dm** Domain Names. The corresponding Third Level extensions: **.com.dm/.net.dm/.org.dm** will be Brand-Protected to the Registrant. However, these Third Level extensions: **.com.dm/.net.dm/.org.dm** cannot be configured in the DM zone.

.edu.dm - suffix is restricted to Educational Institutions registered and accredited for operating in the Commonwealth of Dominica.

.gov.dm - suffix is restricted for use by the Government of the Commonwealth of Dominica.

How many and what types of character can a domain name contain

.DM Domain names may contain a minimum of **1** to a maximum of **63** characters. However, only **alpha** characters (A-Z) may be registered. Spaces are not allowed. Domain Names are **not** case sensitive.

Premium Domain Names

.DM Domain Names which contain 1, 2 and 3 **alpha** characters as well as particular generic names are viewed as holding a higher value over other **.dm** names. These Names are considered Premium Domain Names. A Request for Registration may be submitted to a **.DM** Accredited Registrar at: <https://nic.dm/registrars.php> or to service@dotdm.dm .

Reserved and Restricted / Blocked Domain Names

In consideration of the need to preserve the .DM Registry's stability and security and further, in consideration of the need to protect certain Government or State's operations, particular domain names have been Reserved or are Restricted/Blocked from registration. DM Registry does not publish a list of these names.

Requests for Registration of Domain Names containing the name "**Dominica**" require special processing in collaboration with the Ministry of National Security and Legal Affairs. Requests for Registration may be submitted to service@dotdm.dm.

Requests for Registration for .DM domain names related to Banking, Crypto-currencies, Fintech Services and Internet/ Online Gaming will be rejected.

Internet/ Online Gaming is not authorized in the Commonwealth of Dominica.

Where can I register .dm domains?

.DM domain names are available through select Accredited Registrars and their Resellers committed to supporting the goals and mission of the DotDM Corporation's Domain Name Registry. You may contact a **.DM** Accredited Registrar listed at: <https://nic.dm/registrars.php> .

Residents of the Commonwealth of Dominica may contact **.DM** Registrar Services at: <https://dadomains.nic.dm/contact.php>

How can I find out if a domain name is available?

A search can be made at: <https://whois.dmdomains.dm/> to determine whether a domain name is available for submission of a Request for Registration to **.DM** Registry.

An offer for registration can be submitted to **.DM** Registry for consideration through **(a)** one of our International Registrars viewed at: <https://nic.dm/registrars.php> or **(b)** by email to: service@dotdm.dm for Residents of the Commonwealth of Dominica.

What is the period of registration for a .dm domain name?

.DM Domains are available for registration for a term from 1-10 years.
A Domain Name may be renewed for up to 10 years from the current expiration date.

How much does a .dm registration cost?

The retail price of a .dm domain name registration is determined by each Registrar and their Resellers. Please consult your Registrar for pricing details.

What are my privacy rights?

.DM Privacy Policy can be reviewed at: <https://www.nic.dm/policies/pdf/DMPrivacy2019.pdf>.
.DM will not release a Registrant's phone number, address or email contact details without the consent of the Registrant or unless, under the circumstances detailed in "Use and Disclosure" section, Clause 5 of the .DM Privacy Policy.

How do I transfer my domain name to another Registrar?

In order to transfer a domain name to the management of another Registrar please contact the current Registrar to begin the process and to ensure compliance with all .DM Transfer Policies. .DM Registry does not permit Transfers within the first 60 days of initial registration of a domain name. Domain names which are successfully transferred will be automatically renewed for one (1) additional year.

How do I transfer the domain name to another registrant?

In order to transfer a domain name to another registrant, please contact your Registrar to begin the process and to ensure compliance with all .DM Transfer Policies.

What is the procedure for renewing a Domain?

The .DM Registry follows the principle of an “AUTO-RENEW” Registry.

.DM Registrars are required to manage deletion requests with their Clients prior to the expiration date of their domain name.

Renewal Notifications are sent on regular intervals, prior to the renewal date of a Domain Name, to the email address in the Domain Name Record.

Registrants are urged to maintain current contact details in compliance with the **.DM** Registration Agreement viewed at:

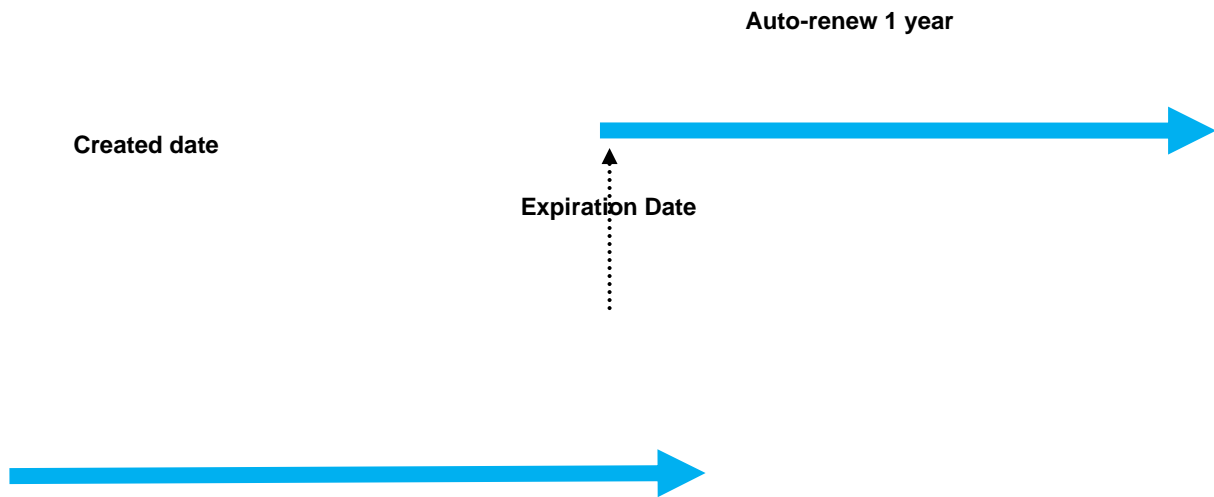
Failure to respond to renewal notifications will result in deletion of a Domain.

A Domain Name which has been explicitly deleted by a .DM Registrar, may be restored at the request of a Registrant. A Fee will apply to a Domain Name which has been explicitly deleted and restored, in addition to the Standard Annual Renewal Fee.

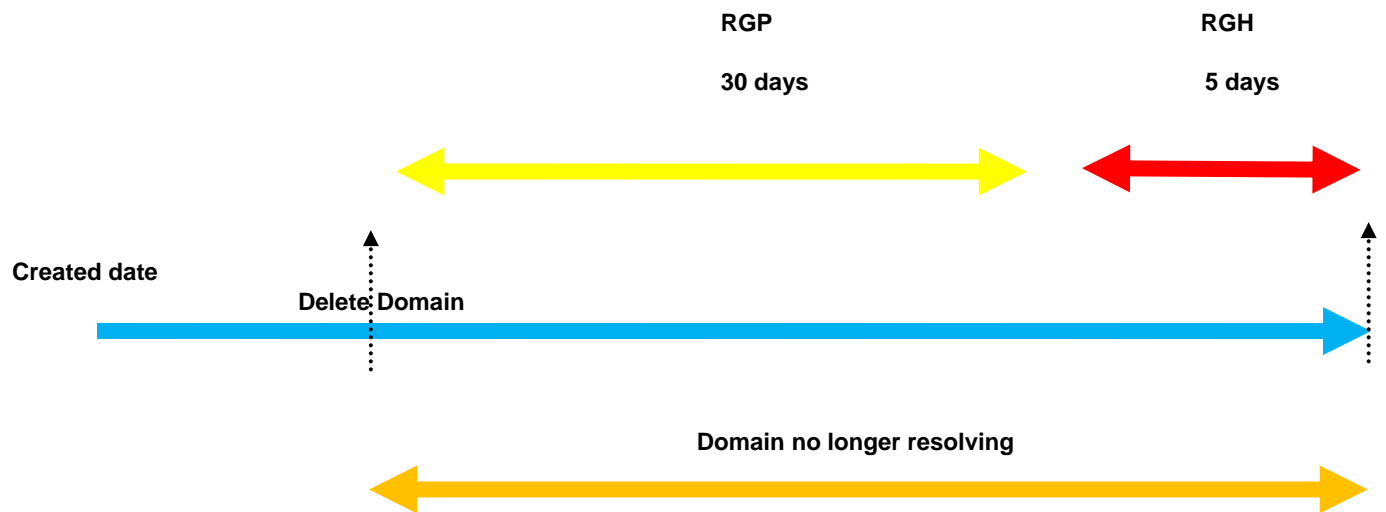
